The Directorate General of Special Education (DGSE), M/o FE&PT Islamabad, invites applications for prequalification from well-reputed, experienced and financially sound firms, suppliers, contractors and service providers, duly registered with the SECP / Registrar of Firms / PEC (as applicable) and with the Income Tax and Sales Tax authorities for the following:

2. Interested firms may apply for one or more lots. A separate bid security of Rs. 500,000/- (Rupees Five Hundred Thousand only) shall be furnished for each lot applied for, in the form of a Bank Draft / Pay Order / CDR drawn in favour of the Director (Admin), DGSE, Islamabad. The original instrument shall reach the office of the undersigned on or before the closing date and time. Applications received without original bid security shall not be entertained.
3. The complete prequalification document, containing the detailed requirements, evaluation criteria and scope of work for each lot, is available on the websites of the Ministry (www.mofept.gov.pk), PPRA website, and can be obtained from the office of the undersigned.
4. Applications shall be submitted manually on or before **August 19, 2026 at 02:00 p.m.**, and shall be opened on the same day at **02:30 p.m.** in the presence of the applicants who choose to attend.
5. The objective of the intended open framework agreement is to enable the on-demand execution of the aforementioned lots, on an as-and-when-required basis, at pre-agreed terms and conditions over the agreed period.
